\*\*NOTE: Sewer impact fee for residential construction is based on the number of water closets, dishwashers, and clothes washers. For each fixture a charge of \$65, not to exceed \$500, will be added to the permit cost. Sewer impact fee for commercial construction is based on the number of water closets, urinals, dishwashers, and clothes washer. For each fixture a charge of \$65 will be added to the permit cost.

**NOTICE: Applicant please read the following and sign below to complete this application.**

- All plumbing installation shall meet the State sanitary code (1991 Standard Plumbing Code with the 1992 Amendments).

**LOCATE SEWER LINE BEFORE COMMENCEMENT OF WORK.**

- Plumbing permit must be obtained before starting work.
- Drains below finished slab must have a minimum inside diameter of two inches (2").
- Copper tubing below the finished slab must be type "K."
- All plumbing under ground must be inspected before back filling.
- This permit becomes null and void if work or construction authorized is not commenced within 6 months, or if construction or work is suspended or abandoned for a period of 6 months at any time after work is commenced.
- I hereby certify that I have read and examined this application and know the same to be true and correct. All provisions of law and ordinances governing this type of work will be complied with whether specified herein or not. The granting of a permit does not presume to give authority to violate or cancel the provision of any other state or local law regulating construction or the performance of construction.
