

Since the publication of the resolution and *Procès Verbal* constitute the official promulgation of the election results, it is important that these proceedings be published on **December 9, 2015**. Please note that it will not be necessary to republish these proceedings when the remainder of the minutes of the December 1, 2015 meeting are published.
